

CONTRACT REFUND GUARANTEE

The organization of the Milenio Titan Desert by GAES 2012, offers to the participants the possibility of contract and extra service for the refund of the registration fee in case he cannot attend the race start.

The organization offers a guarantee service to participants in case they cannot attend the race start. The offer improves the cancellation policy included in the registration fee.

Until now, if a participant was not able to attend the race he was able to refund only a part of the amount of the registration depending the date of the cancellation (see cancellation policy above).

With this offer, participants have the chance of hiring a guarantee of refund for the registration fee.

The most common causes of cancellation are the injuries while training or medical problems but now with this guarantee it's not a problem anymore.

If you've hired the guarantee when you made your registration you can cancel your registration until April 13th 03:00pm (GMT+1).

CANCELLATION WITHOUT GUARANTEE – (included in the registration fee)

- Cancellations before December 2nd 2011 will have a charge of 50€.
- Cancellations before January 31st 2012 will have a cost of 50% of the amount paid in concept of registration.
- Cancellations before March 16, 2012 will have a cost of 75% of amount paid in concept of registration.
- Any further cancellation outside these terms will have no refund

CANCELLATION WITH GUARANTEE – (Optional Extra)

- Cancellation before March 30, 2012 will have a 100% refund of the REGISTRATION FEE amount paid until the moment of cancellation.
- Between March 30th 2012 at 03:01pm (GMT+1) and April 13th 2012 at 03:00pm (GMT+1): refund of 50% REGISTRATION FEE amount paid until the moment of cancellation.
- The flight prizes paid will have a 100% refund until January 31st 2012. Flight cancellations from January 31st to April 13th will have a 50% refund.

¿HOW TO CONTRACT THE REFUND GUARANTEE?

IMPORTANT: The guarantee should be contract the same day of registration.

1. - Download and fulfill the form at the end of this document.
2. - Payment by Bank Transfer (90€ contracts until December 2nd 2011 and 110€ contracts from December 3rd until registrations close).

BASIC RULES FOR WARRANTY



The participant signing this guarantee on behalf of himself, say him have read and agree to:

First.- The warranty contract shall be done exclusively on the day of registration. No guarantees will be accepted after enrollment. The payment of it will be made separately indicating the concept of income.

Second.- The Organization will refund the amounts paid until the date of the cancellation of the participant enrollment fee and flights. Payment periods and percentages are detailed above, in case of accident, illness, physical or annulment by choice, which make impossible the participation in the Milenio Titan Desert by Gaes 2012.

Third .- The Organization will return the amounts from June 1, 2012.

Fourth .- The duration of the warranty shall be effective upon receipt of this document with the Procurement Procedure section completed and signed along with proof of payment attached. Valid until the April 13th, 2012 at 3:00pm.

Fifth .- The warranty contract ends on March 16th 2012 or at the close of entries.

Sixth .- The participant will dispatch by fax (93 422 07 21) or email (info@titandesert.com) a copy of this document completed and signed along with the BANK RECEIPT of payment of the guarantee, if the sending is made by fax, he must to notify it by email to ensure proper reception.

Seventh.- We will not accept any warranty not fulfill the first or fifth spot

Eight .- To proceed with the annulment, the participant should send to the organization by email or fax this document along with bank details to make the refund.

IMPORTANT: The bank details for the refund must be the same bank account from which the payment of registration has been done.
